3. Only bicycles with a valid identification tag are allowed to park in the Bicycle Racks on a First-Come-First- Serve Basis.
4. The bicycle tag issued is not transferable for use on another bicycle and must be returned to the Management if the bicycle against which it was issued is no longer parked in the estate.
5. The Management of MCST 2902 reserves the right to change/amend the rules and regulations for the Bicycle parking at any time at its discretion without prior notice given.
6. Bicycles without the bicycle tags will be removed.
7. Bicycles are to be parked at the bicycle stands only and to be kept in good condition.
8. Prams and scooters are not allowed to be parked in bicycle racks.
9. The Management of MCST 2902 shall not be held liable for any theft, damage or other misdemeanor caused. All bicycles parked at Tanamera Crest will be at the owner's risk.
10. Maximum of 3 bicycles is allowed to register per unit on first come first serve basis and subject to availability of lots.
