SECTION 2: RULES & REGULATIONS

1. Coaching hours: Monday – Friday 9am – 3pm

*Strictly NO coaching on weekends or public holidays. The coach is allowed to conduct and utilize only half the length of the swimming pool.

2. A refundable deposit of S\$100.00 (cash or cheque made payable to “MCST 2902”) should accompany the registration form during the application. The Management reserves the right to reject any application without assigning any reason. The deposit shall be forfeited by The Management in the event of any breach of rules & regulations.

3. The Coach is required to submit relevant credential together with the registration form.

4. Monthly fee to the MCST: \$10.70 inclusive of GST (cash or cheque made payable to “MCST 2902”)

5. Student(s) must be residents of Tanamera Crest.

6. The Coach is required to submit an updated list of students monthly or quarterly. Maximum four (04) students allowed per lesson/session.

7. Proper swimming attire, deemed acceptable by the Management, must be worn at all time by the Coach and the student(s) when they are using the swimming pool.

8. The Coach and the student(s) must vacate the swimming pool once the lesson/session ends.

9. The Coach shall be responsible for the behaviour of his/her student(s) at all time.

10. The Coach shall inform the Management of any changes in his/her training schedule.

11. The Coach shall notify the Management when he/she ceases to be the Coach of Tanamera Crest.

12. The Coach shall indemnify the Management and its Managing Agent against any actions, claim and liability for any injury, loss of life or damage to property whatsoever so caused relating to or arising from his/her coaching lesson/session.

13. The Management reserves the right to amend any rules, regulations and clauses; revoke any permission granted and review the fees charged without assigning any reason. Such decisions shall be deemed final and non-negotiable.

SECTION 3: JOINT INDEMNITY AGREEMENT

In consideration for being permitted into the condominium to conduct swimming lessons/sessions to the residents of Tanamera Crest (as stated in Section 1), I/We solely & jointly declare that I/we shall indemnify the Management and its Managing Agent against any actions, claim & liability for any injury, loss of life or damage to property whosoever so caused relating to or arising from the coaching lesson/ session.

The deposit of S\$100.00 will be held as security for any actions, claims & liability for any injury, loss of life or damage to property. Such deposit is to be issued in favour of "MCST 2902" free of interest and subject to the applicant's compliance with all the conditions stated herein. In the event of the deposit being insufficient to meet the Management's claim, the applicant shall compensate the difference between the said deposit and the amount so claimed by the Management. The said deposit shall be forfeited if any of the conditions stated herein is not complied with.

I/We will undertake to be responsible for the behaviour of the students and comply with the rules and regulations as stipulated in Section 2, otherwise the Management reserves the right to stop the lessons/sessions due to non-compliance of the above rules and regulations.

I/We have read & understood the above rules & regulations & I agree to observe these rules & regulations if the application is accepted by the Management. I do understand that the Management is not obliged to accept my application & the Management can withdraw the permission granted to me to conduct lessons in Tanamera Crest if I do not comply with the rules and regulations or misbehave myself in anyway.

Before the commencement of the lesson schedule:

- a. Please submit a cheque of S\$100.00 (made payable to "MCST 2902") as refundable deposit and a monthly fee of S\$10.70 (inclusive of GST) for the first coaching month.
- b. The coach is required to submit a copy of his/her credentials and the lesson/session schedule together with the registration & indemnity forms.
